This Supplemental/ Bid Bulletin no. 6 dated January 31, 2022 for the project: "CONSTRUCTION OF FIVE-STOREY RESOURCE MANAGEMENT BUILDING- PHASE 2 (INFRA-2022-01)", is issued to modify or amend items in the Bid Document, and to address queries/ clarifications sent by bidder through e-mail in compliance with Section 25.5.1 of the 2016 Revised IRR of RA 9184.

I. REPLY TO QUERIES/CLARIFICATIONS SENT BY THE BIDDER THROUGH E-MAIL

QUERIES/CLARIFICATIONS	ANSWER
May we clarify that there is no color requirement, and please see attached photos if this is the correct and required sealing and marking of bid format."	There is no color requirement in the sealing and marking of bids in the Bidding documents. We have required what is stipulated in Republic Act 9184 and the 6th Edition Bidding Documents. Concerning the question, if the photo attached is correct and requires sealing and marking of bid format, Section 25.1 Submission and Receipt of Bids of RA 9184 requires that the bids be submitted simultaneously in two (2) separate sealed bid envelopes. Moreover, Section 16 Sealing and Marking of Bids of 6th
	Edition Bidding Documents provides: Each Bidder shall submit one copy of the first and second components of its Bid.
	May we clarify that there is no color requirement, and please see attached photos if this is the correct and required

The Procuring Entity may request additional hard copies and/or electronic copies of the Bid. However, the failure of the Bidders to comply with the said request shall not be a ground for disqualification.

Thus, Bulacan State University requires in the Bidding Documents the following:

Each Bidder shall submit one (1) original or certified true copy of the technical and financial bid components and an additional three (3) photocopies of the same. However, the failure of the bidders to provide the additional copies shall not be a ground for disqualification.

Based on the above, there is no specific color requirement nor the position of each copy of the bid envelopes, as long as the Bidder shall submit one (1) original or certified true copy of the technical and financial bid components and an additional three (3) photocopies of the same in accordance with the Bidding Documents requirements.

This Supplemental/Bid Bulletin no. 6 shall form part of the Bidding Documents. All terms, conditions, and instructions to bidders specified in the Bidding Documents inconsistent herewith are hereby superseded and modified accordingly.
