

1	<p>"May we request for us to use the same Key Personnel for the projects Repair of Storage Rooms and Comfort Room (3rd Floor) at Federizo Hall, Replacement of Roofing at Carpio Hall, Repair of Ground Floor to Fourth Floor Public Restrooms at Roxas Hall, and Negotiated Procurement: Two-failed biddings Establishment of Bulacan Cultural Material Laboratory?</p> <p>Hoping for your consideration on this matter."</p>	<p>Government Procurement Policy Board (GPPB) circulars and resolutions do not state prohibition on the submission of a list of contractor's key personnel containing the same names by a bidder who participates in two (2) or more projects.</p> <p>Non-Policy Matter (NPM) Opinion 051-2012 of GPPB provides:</p> <p>X X X</p>

		<p>"(2) Whether the submission of a list of contractors personnel containing the same names by a bidder who participates in two (2) or more projects results in his disqualification.</p> <p><u>The inclusion of the same personnel by the same bidder in several of its bid proposals should not be a ground for disqualification for being too restrictive and limiting."</u></p> <p>Based on the above provisions, a bidder may use the same key personnel for the four (4) infrastructure projects. Besides, there is no assurance yet that any bidder/s will get the award of contract for any or all four (4) projects because there is still a bid opening stage and post-qualification process.</p> <p>What is more important is the availability of these key personnel in the Project implementation stage. Thus, if ever two (2) or more contracts will be awarded to a bidder, the Bulacan State University will require a different set of key personnel for each project.</p>
