In view of the two (2) failed public biddings as resolved in Bulacan State University (BulSU) BAC Resolution nos. G-2018-123 and G-2018-221, the BulSU through the Income Fund 2018 intends to apply the sum of Seven Hundred Four Thousand Pesos Only (₱ 704,000.00) for Lot 1- 5-seater gang chair with tablets and Two Hundred Ninety-Six Thousand Pesos Only (₱ 296,000.00) for Lot 2- Fabricated Chairs and Tables with an aggregate amount of One Million Pesos (₱ 1,000,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for "Negotiated Procurement of Furniture and Fixture for Sarmiento Campus".

1. Registration certificate from the Securities and Exchange Commission (SEC) or Department of Trade and Industry (DTI) for sole proprietorship;
2. Mayor's permit issued by the city or municipality where the principal place of business of the prospective bidder is located; and
3. Audited financial statements, stamped "received" by the Bureau of Internal Revenue (BIR) or its duly accredited and authorized institutions, for the preceding calendar year, which should not be earlier than two (2) years from bid submission
4. NFCC computation in accordance with ITB Clause 5.5 or a committed Line of Credit from a universal or commercial bank
5. PhilGEPS Certificate of Registration and Membership
Platinum category in accordance with Section 8.5.2 of the IRR (12.1 a i)

Technical Documents

6. Statement of the Bidder's Single Largest Completed Contract (SLCC) within the last three (3) years which is similar in nature.

7. Statement of all its on-going government and private contracts, including contracts awarded but not yet started, **if any**.
8. Bid Security / Bid Securing Declaration
9. Statement of conformity with schedule of requirements and technical specifications
10. Brochures or catalogues of items being offered or clear copy of print-out if downloaded from the internet;
11. Manufacturer's Authorization Form or Certificate from Manufacturer as Distributor or Reseller
12. Warranty Certificate;
13. Omnibus Sworn statement in accordance with Section 25.3 of the IRR of RA 9184 and using the form prescribed herein as **(FORM "D")**


