

## INVITATION TO APPLY FOR ELIGIBILITY AND TO BID (INFRA-2014-08)

The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criterion. Post-qualification of the lowest calculated bid shall be conducted.
