### INVITATION FOR NEGOTIATIONS:

Negotiated Procurement of Mini Bus and Sedan for Bulacan State University Project reference no. (G-2019-01)

In view of the two (2) failed public biddings as resolved in Bulacan State University (BulSU) BAC Resolution nos. G-2018-432 and G-2018-489, the BulSU through the General Fund 2019 intends to apply the sum of Eight Million Pesos Only (\$\bigsite\$ 8,000,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for "Negotiated Procurement of Mini Bus and Sedan for Bulacan State University" consisting of two (2) units mini-bus and one (1) unit sedan.

The following eligibility and technical documents, as well as the Financial Proposal Form (Form "E") and itemized bid prices (Form "F"), shall be submitted on or before February 4, 2019 (Monday), 10:00 a.m. at Procurement Office 2<sup>nd</sup> Floor, CSSP Building (near Gate 4), Bulacan State University, City of Malolos, Bulacan. The number of set of documents is one (1) original and three (3) certified photocopies of the first (Eligibility/Technical) and second components (Financial) of its bid duly signed and sealed:

- 1. Registration certificate from the Securities and Exchange Commission (SEC) or Department of Trade and Industry (DTI) for sole proprietorship:
- 2. Mayor's permit issued by the city or municipality where the principal place of business of the prospective bidder is located; and
- 3. Audited financial statements, stamped "received" by the Bureau of Internal Revenue (BIR) or its duly accredited and authorized institutions, for the preceding calendar year, which should not be earlier than two (2) years from bid submission
- 4. NFCC computation in accordance with ITB Clause 5.5 or a committed Line of Credit from a universal or commercial bank

- 5. Statement of the Bidder's Single Largest Completed Contract (SLCC) within the last three (3) years which is similar in nature.
- 6. Statement of all its on-going government and private contracts, including contracts awarded but not yet started, *if any*.

- 8. Statement of conformity with schedule of requirements and technical specifications
- Certification from Land Transportation Office (LTO) accredited manufacturer or importer attesting to the availability of authorized dealers and service centers in all regions of the country from the last ten (10) years

- 12. Brochure or catalogues of items being offered or clear copy of print-out if downloaded from the internet of the same
