The prospective bidder must have completed a Single Largest Completed Contract (SLCC) that is similar to the contract to be bid, and whose value, adjusted to current prices using the PSA consumer price indices, must be at least fifty percent (50%) of the ABC to be bid: Provided, however, that contractors under Small A and Small B Categories without similar experience on the contract to be bid may be allowed to bid if the cost of such contract is not more than the Allowable Range of Contract Cost (ARCC) of their registration based on the guidelines as prescribed by the PCAB. The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criterion. Post-qualification of the lowest calculated bid shall be conducted.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference(s), Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulations (IRR).

INVITATION TO BID FOR PROPOSED EXECUTIVE VILLA (INFRA-2020-10)

- 1. The Bulacan State University (BulSU), through the Income Fund 2020 intends to apply the sum of Seven Million Four Hundred Ninety Nine Thousand Two Hundred Sixty Eight Pesos and 16/100 (\$\mathbf{P}\$ 7, 499,268.16) being the Approved Budget for the Contract (ABC) to payments under the contract for Proposed Executive Villa (INFRA-2020-10) Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Bulacan State University (BulSU) now invites bids for Proposed Executive Villa (INFRA-2020-10). Completion of the Works is required within One Hundred Eighty (180) calendar days upon receipt of Notice to Proceed. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II- Instruction to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
 - Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
- 4. Interested bidders may obtain further information from *Bulacan State University* and inspect the Bidding Documents at the address given below during *office hours from 8:00 a.m. to 5:00 p.m., Monday to Friday (Except on holidays).*
- A complete set of Bidding Documents may be acquired by interested Bidders on *January* 20, 2020 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Eight Thousand Pesos (\$\mathbb{P}\$8,000.00). It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the

website of the Bulacan State University, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than *February 11, 2020*.

6. The Bulacan State University will hold a Pre-Bid Conference on January 28, 2020 (Tuesday), 1:30 p.m. at the BAC Function Room, 3rd Floor, Hostel, BulSU, Main Campus,

City of Malolos, Bulacan 3000, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat at the address below on or before *February 11, 2020 (Tuesday), 1:30 p.m.* All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause - 18.

Bid opening shall be on *February 11, 2020 (Tuesday), 1:30 p.m.* at the BAC Function Room, 3rd Floor, Hostel, BulSU Main Campus, City of Malolos, Bulacan 3000. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The *Bulacan State University* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
