## Invitation to Bid: Multi-Year Development of Five-Storey Resource Management Building for BulSU Campus (Infra-2021-01)

- 1. The Bulacan State University, through the FY 2021General Appropriations Act, intends to apply the sum of Sixty Two Million Five Hundred Thirty-Four Thousand Pesos (₱62,534,000.00) and FY 2021 Program of Receipts and Expenditures (P.R.E.) Income Fund amounting to Twenty Million Ninety-Three Thousand Six Hundred Ninety Four Pesos and 19/100 (₱ 20,093,694.19) with an aggregate amount of Eighty Two Million Six Hundred Twenty Seven Thousand Six Hundred Ninety Four Pesos and 19/100 (₱ 82,627,694.19) being the Approved Budget for the Contract (ABC) to payments under the contract for Multi-Year Development of Five-Storey Resource Management Building for BulSU Campus (Infra-2021-01). Bids received in excess of the ABC shall be automatically rejected at bid opening.
- The Bulacan State University now invites bids for the above Procurement Project. Completion of the Works is required Two Hundred Forty (240) calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- Bidding will be conducted through open competitive bidding procedures using nondiscretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Interested bidders may obtain further information from the BulSU-Bids and Awards Committee (BAC) Secretariat through the contact details given below and inspect the Bidding Documents as posted on the websites of the BulSU and the Philippine Government Electronic Procurement System (PhilGEPS).
- 5. A complete set of Bidding Documents may be acquired by interested bidders on **December 22, 2020** from given address and website/s below and upon payment of the applicable fee for the Bidding Documents in the amount of Fifty Thousand Pesos (\$\mathbf{P}\$ 50,000.00).
- 6. The Bulacan State University will hold an Online Pre-bid Conference on January 7, 2021 (Thursday), 1:30 p.m., which shall be open to all interested parties. - 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.
- Bid Opening shall be on January 19, 2021 (Tuesday), 1:30 p.m. at the Receiving Area of Cashier and Registrar's Office, Flores Hall, BulSU Main Campus, City of Malolos, Bulacan 3000. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. To minimize face to face transaction with the public, only one (1) representative for each bidder will be allowed during the opening of bids.
- The Bulacan State University reserves the right to reject any and all bids, declare a 11. failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
