

CONTRACT AGREEMENT

THIS AGREEMENT, made this 010521 day of December, 2020 between **BULACAN STATE UNIVERSITY** with principal office and postal address at **Brgy. Guinhawa, City of Malolos, Bulacan 3000 of the Philippines** represented by its President **Dr. CECILIA N. GASCON** (hereinafter called the "Entity") and **MDEC CORPORATION** with postal address at **No. 15 Maningning Street, Sikatuna Village, Quezon City** represented herein by its General Manager **Engr. ENRICO A. ALDAY** (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute "**RENOVATION OF CLASSROOMS AT THE COLLEGE OF INFORMATION AND COMMUNICATIONS TECHNOLOGY BUILDING (INFRA-2020-11)**" (hereinafter called "the Works") and the Entity has accepted the Bid for **Three Million Pesos (₱ 3,000,000.00), net of discount**, by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, *viz.*:
 - a. Philippine Bidding Documents (PBDs);
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract (**completion period within Ninety (90) calendar days**);
 - v. Supplemental or Bid Bulletins, if any;
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - c. Performance Security;
 - d. Notice of Award of Contract and the Bidder's conforme thereto; and
 - e. Other contract documents or information that may be required by existing laws and/or the Procuring Entity concerned in the PBDs from the **winning bidder, including but not limited to those prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, which shall likewise form as integral parts of the Contract (GPPB Resolution No. 16-2020, dated 16 September 2020).**



IN WITNESS whereof the parties thereto have caused this Agreement to be executed the day and year first before written.




