The BULACAN STATE UNIVERSITY (BulSU), through its Bids and Awards Committee (BAC), invites contractors to apply for eligibility and bid for the project hereunder described:

Name of Project : **Audio Visual Room at College of Law**  
Location : **Bulacan State University (Main Campus), City Malolos, Bulacan**  
Scope of Work : **General Requirements, Site Preparatory Works, Masonry Works, Carpentry Works, Metal Works, Tiling Works, Painting Works, Fenestrations, Electrical Works, and Furniture and Equipment**  
PCAB License : **Size Range – Small B, License Category- C & D**  
Similar Project : **Commercial Interior Fit-outs or renovation as specified in the scope of works, costing at least fifty percent (50%) of the ABC amounting to P 1,426,872.77**  
ABC : **P 2,853,745.54**  
Completion Date : **Sixty (60) calendar days**

The prospective bidder must have completed a Single Largest Completed Contract (SLCC) that is similar to the contract to be bid, and whose value, adjusted to current prices using the PSA consumer price indices, must be at least fifty percent (50%) of the ABC to be bid: Provided, however, that contractors under Small A and Small B Categories without similar experience on the contract to be bid may be allowed to bid if the cost of such contract is not more than the Allowable Range of Contract Cost (ARCC) of their registration based on the guidelines as prescribed by the PCAB. The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criterion. Post-qualification of the lowest calculated bid shall be conducted.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference(s), Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulations (IRR).

The *Bulacan State University*, through the *FY 2021 Income Fund*, intends to apply the sum of *Two Million Eight Hundred Fifty Three Thousand Seven Hundred Forty Five Pesos and 54/100 (₱ 2,853,745.54)* being the Approved Budget for the Contract (ABC) to payments under the contract for **Audio Visual Room at College of Law (Infra-2021-13)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Bulacan State University* now invites bids for the above Procurement Project. Completion of the Works is required *Sixty (60) calendar days*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from the BulSU-Bids and Awards Committee (BAC) Secretariat through the contact details given below and inspect the Bidding Documents as posted on the websites of the BulSU and the Philippine Government Electronic Procurement System (PhilGEPS).
5. A complete set of Bidding Documents may be acquired by interested bidders on *March 26, 2021* from given address and website/s below *and upon payment of the applicable fee for the Bidding Documents in the amount of Three Thousand Pesos (₱ 3,000.00)*.
6. The *Bulacan State University* will hold an Online Pre-bid Conference on **April 6, 2021 (Tuesday), 1:30 p.m.**, which shall be open to all interested parties. To reduce the risks and hazards of community transmission of COVID-19, the BAC shall conduct meetings and conferences via Google Meet platform at [https:// meet.google.com/age-pzoc-xnb](https://meet.google.com/age-pzoc-xnb), until further notice, or until such time that the state of calamity, or implementation of community quarantine or similar government restrictions shall have been lifted by the proper government authorities.

8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 16**.
9. Bid Opening shall be on **April 19, 2021 (Monday), 2:30 p.m.** at Valencia Hall (Front), BulSU Main Campus, City of Malolos, Bulacan 3000. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. To minimize face to face transaction with the public, **only one (1) representative** for each bidder will be allowed during the opening of bids.

The ***Bulacan State University*** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
