The **BULACAN STATE UNIVERSITY (BuSU)**, through its **Bids and Awards Committee (BAC)**, invites contractors to apply for eligibility and bid for the project hereunder described:

Name of Project : Various Repair and Improvement for Bustos Campus
Location : Bulacan State University, Bustos Campus
ABC : Php 2,459,134.59
Completion Date : Ninety (90) calendar days

The prospective bidder must have completed a Single Largest Completed Contract (SLCC) that is similar to the contract to be bid, and whose value, adjusted to current prices using the PSA consumer price indices, must be at least fifty percent (50%) of the ABC to be bid: Provided, however, that contractors under Small A and Small B Categories without similar experience on the contract to be bid may be allowed to bid if the cost of such contract is not more than the Allowable Range of Contract Cost (ARCC) of their registration based on the guidelines as prescribed by the PCAB. The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criterion. Post-qualification of the lowest calculated bid shall be conducted.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference(s), Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulations (IRR).

The **BULACAN STATE UNIVERSITY (BuSU)**, through the **Income Fund** intends to apply the sum of **Two Million Four Hundred Fifty Nine Thousand One Hundred Thirty Four Pesos and 59/100 (Php 2,459,134.59)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Infra-2017-06**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The **Bulacan State University** now invites bids for **Various Repair and Improvement for Bustos Campus Infra 2017-06**. Completion of the Works is required within **Ninety (90) calendar days upon receipt of Notice to Proceed**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from **Bulacan State University** and inspect the Bidding Documents at the address given below **during regular office days, from 8:00 am to 5:00pm**.

A complete set of Bidding Documents may be acquired by interested bidders on **July 21, 2017 (Friday)** from the address below and upon payment of a non-refundable fee for the Bid Documents in the amount of **Three Thousand Pesos Only (Php 3,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the **Bulacan State University**, provided that bidders shall pay the fee for the Bidding Documents not later than the day of submission of their bids.

The **Bulacan State University** will hold a **Pre-Bid Conference** on **July 28, 2017 (Friday), 1:30 p.m.** at the **Function Room A, 2nd Floor Flores Hall, BuSU Main Campus, Bulacan State University, Guinhawa, City of Malolos, Bulacan**, which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat at the address below on or before **August 10, 2017 (Thursday), 1:30 p.m. at the Function Room A, 2nd Floor Flores Hall, BuSU Main Campus, Bulacan State University, Guinhawa, City of Malolos, Bulacan**.

All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **August 10, 2017 (Thursday), 1:30 p.m. at the Function Room A, 2nd Floor Flores Hall, BuSU Main Campus, Bulacan State University, Guinhawa, City of Malolos, Bulacan**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The **Bulacan State University** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
