The **BULACAN STATE UNIVERSITY (BulSU)**, through its **Bids and Awards Committee (BAC) for Goods, Supplies, and Services**, invites suppliers/manufacturers/distributors to apply for eligibility and to bid for the hereunder project:

Name of Project: **Annual Medical Examination for BulSU Personnel**
Location : **Bulacan State University, City of Malolos, Bulacan**
ABC : **Php 3,000,000.00**
Delivery Period : **Seven (7) Working Days upon Extraction**

Prospective bidders should have an experience of having completed within the last three (3) years a single contract that is similar to the contract to be bid, and whose value, adjusted to current prices using the wholesale consumer price index, must be at least fifty percent (50%) of the approved budget for the contract to be bid. The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criterion. Post-qualification of the lowest calculated bid shall be conducted.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference(s), Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Revised Implementing Rules and Regulations (IRR).

**INVITATION TO BID FOR
Annual Medical Examination for BulSU Personnel
(G-2021-17)**

1. The *Bulacan State University (BulSU)*, through the *Income Fund 2021* intends to apply the sum of *Three Million Pesos Only (₱ 3,000,000.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for *Annual Medical Examination for BulSU Personnel (G-2021-17)*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Bulacan State University (BulSU)* now invites bids for *Annual Medical Examination for BulSU Personnel (G-2021-17)*. Delivery of the Goods is required within *Seven (7) working days upon extraction, upon receipt of Notice to Proceed and Purchase Order*. Bidders should have completed, *within the last three (3) years* from the date of submission and receipt of bids (September 20, 2021), a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from *Bulacan State University* and inspect the Bidding Documents at the address given below during *office hours from 8:00 a.m. to 5:00 p.m., Monday to Thursday (Except on holidays)*.

A complete set of Bidding Documents may be acquired by interested Bidders on *August 28 to September 20, 2021* from the address below and website *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Three Thousand Pesos Only (₱ 3,000.00) thru our Cashier or Bulacan State University - Landbank account number: 2792-100522.*

The Procuring Entity shall allow the bidder to present its proof of payment for the fees presented in person, or through electronic means (thru our e-mail address at bulsu.bac2secretariat@bulsu.edu.ph).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Bulacan State University, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than **September 20, 2021**.

5. The **Bulacan State University** will hold a Pre-Bid Conference on **September 6, 2021 (Monday), 2:00 p.m.** through video conferencing or webcasting via **Google Meet** (<https://meet.google.com/dzq-bfms-wgd>), which shall be open to prospective bidders.
6. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before **September 20, 2021 (Monday), 8:30 a.m.** Late bids shall not be accepted.
7. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
8. Bid opening shall be on **September 20, 2021 (Monday), 8:35 a.m.** in Front of Valencia Hall, Bulacan State University, Brgy. Guinhawa, City of Malolos, Bulacan 3000. Bids will be opened in the presence of the bidders' representative who choose to attend the activity, only one official representative per bidder is allowed due to the health protocol of limited public gatherings restriction
9. The **Bulacan State University** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
