The inclusion of the same personnel by the same bidder in several of its bid proposals should not be a ground for disqualification for being too restrictive and limiting."

Based on the above provisions, a bidder may use the same key personnel for the four (4) infrastructure projects. Besides, there is no assurance yet that any bidder/s will get the award of contract for any or all four (4) projects because there is still a bid opening stage and post-qualification process.

What is more important is the availability of these key personnel in the Project implementation stage. Thus, if ever two (2) or more contracts will be awarded to a bidder, the Bulacan State University will require a different set of key personnel for each project.

This Supplemental/Bid Bulletin no. 1 shall form part of the Bidding Documents. All terms, conditions and instructions to bidders specified in the Bidding Documents inconsistent herewith are hereby superseded and modified accordingly.
