Re-negotiated Procurement of Service Vehicles for Bulacan State University
Project reference no. (G-2018-03)

In view of the two (2) failed public biddings and one (1) negotiation as resolved in Bulacan State University (BulSU) BAC Resolution nos. G-2017-428, G-2018-001, and G-2018-076, the BulSU through the Income Fund 2018 intends to apply the sum of Five Million One Hundred Thousand Pesos Only (₱ 5,100,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for "Re-negotiated Procurement of Service Vehicles for Bulacan State University" consisting of one (1) asian utility vehicle and two (2) units passenger van.

The following eligibility and technical documents, as well as the Financial Proposal Form (**Form "E"**) and itemized bid prices (**Form "F"**), shall be submitted on or before **April 17, 2018 (Tuesday), 9:00 a.m.** at Procurement Office 2nd Floor, CSSP Building (near Gate 4), Bulacan State University, City of Malolos, Bulacan. The number of set of documents is **one (1) original and two (2) certified photocopies of the first (Eligibility/Technical) and second components (Financial) of its bid duly signed and sealed:**

Legal Documents

1. Registration certificate from the Securities and Exchange Commission (SEC) or Department of Trade and Industry (DTI) for sole proprietorship;
2. Mayor's permit issued by the city or municipality where the principal place of business of the prospective bidder is located; and
3. Audited financial statements, stamped "received" by the Bureau of Internal Revenue (BIR) or its duly accredited and authorized institutions, for the preceding calendar year, which should not be earlier than two (2) years from bid submission
4. NFCC computation in accordance with ITB Clause 5.5 or a committed Line of Credit from a universal or commercial bank

Technical Documents

5. Statement of the Bidder's Single Largest Completed Contract (SLCC) within the last three (3) years which is similar in nature.
6. Statement of all its on-going government and private contracts, including contracts awarded but not yet started, **if any**.
7. Bid Security / Bid Securing Declaration
8. Statement of conformity with schedule of requirements and technical specifications

9. Certification from Land Transportation Office (LTO) accredited manufacturer or importer attesting to the availability of authorized dealers and service centers in all regions of the country from the last ten (10) years
10. Manufacturer's Authorization Form or Certificate as Authorized Distributor/Reseller or Certificate of Registration as Manufacturer /Fabricator
11. Warranty Certificate;
12. Brochure or catalogues of items being offered or clear copy of print-out if downloaded from the internet of the same
13. Omnibus Sworn statement in accordance with Section 25.3 of the IRR of RA 9184 and using the form prescribed herein as **(FORM "D")**
