INVITATION TO BID FOR

CHEMISTRY LABORATORY EQUIPMENT FOR THE COLLEGE OF
SCIENCE (LOT-2)

1. The *Bulacan State University (BulSU)*, through the *Fiduciary Fund 2018* intends to apply the sum of *Eight Hundred Ninety Five Thousand Pesos Only (P895,000.00)* for *Lot-1* and *Six Hundred Two Thousand Pesos (P602,000.00)* for *Lot -2* being the Approved Budget for the Contract (ABC) to payments under the contract for *Procurement of Biology Laboratory Equipment, Environmental Science and Chemistry Laboratory Equipment for the College of Science (G-2018-08)*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Bulacan State University (BulSU)* now invites bids for *Procurement of Biology Laboratory Equipment for the College of Science (Lot-1) and Environmental Science and Chemistry Laboratory Equipment for the College of Science (Lot-2) (G-2018-08)*. Delivery of the Goods is required *within Thirty (30) calendar days upon receipt of Notice to Proceed and Purchase Order*. Bidders should have completed, *within the last three (3) years* from the date of submission and receipt of bids (May 21, 2018), a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

In addition, bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from **Bulacan State University** and inspect the Bidding Documents at the address given below during *office hours from 8:00 a.m. to 5:00 p.m., Monday to Friday (Except on holidays)*.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **April 30 to May 21, 2018** from the address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of One Thousand Pesos (₱ 1,000.00) for Lot 1 and Six Hundred Pesos (₱ 600.00) for Lot 2*

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Bulacan State University, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than **May 21, 2018**.

6. The **Bulacan State University** will hold a Pre-Bid Conference on **May 8, 2018 (Tuesday), 9:00 a.m.** at the Accreditation Room, G/F, Natividad Hall, BulSU Main Campus, City of Malolos, Bulacan, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **May 21, 2018 (Monday), 1:30 p.m.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **May 21, 2018 (Monday), 1:30 p.m.** at the Accreditation Room, G/F, Natividad Hall, BulSU Main Campus, City of Malolos, Bulacan. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The **Bulacan State University** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
