INVITATION TO BID FOR

Re-bidding: Procurement of various furniture and fixture for Sarmiento Campus (G-2018-05)

- 1. The Bulacan State University (BulSU), through the Income Fund 2018 intends to apply the sum of Seven Hundred Four Thousand Pesos Only (\$\mathbb{P}\$ 704,000.00) for Lot 1-5-seater gang chair with tablets and Two Hundred Ninety-Six Thousand Pesos Only (\$\mathbb{P}\$ 296,000.00) for Lot 2- Fabricated Chairs and Tables with an aggregate amount of One Million Pesos (\$\mathbb{P}\$ 1,000,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for each lot. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.
- 2. The Bulacan State University (BulSU) now invites bids for Re-bidding: Procurement of various furniture and fixture for Sarmiento Campus (G-2018-05). Delivery of the Goods is required within Thirty (30) calendar days upon receipt of Notice to Proceed and Purchase Order. Bidders should have completed, within the last three (3) years from the date of submission and receipt of bids (June 26, 2018), a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
 - In addition, bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
- 4. Interested bidders may obtain further information from *Bulacan State University* and inspect the Bidding Documents at the address given below during *office hours from 8:00 a.m. to 5:00 p.m., Monday to Friday (Except on holidays).*

5. A complete set of Bidding Documents may be acquired by interested Bidders on June 5 to June 26, 2018 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Seven Hundred Pesos (\$\mathbf{P}\$700.00) for Lot 1-5-seater gang chair with tablets and Three Hundred Pesos (\$\mathbf{P}\$300.00) for Lot 2- Fabricated Chairs and Tables.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Bulacan State University, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than *June 26, 2018*.

- 6. The *Bulacan State University* will hold a Pre-Bid Conference on *June 13, 2018* (*Wednesday*), 1:30 p.m. at the Accreditation Room, Ground Floor, Natividad Hall, Bulacan State University, Guinhawa, City of Malolos, Bulacan 3000, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat at the address below on or before *June 26, 2018 (Tuesday), 9:00 a.m.* All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on *June 26, 2018 (Tuesday), 9:00 a.m.* at the Accreditation Room, Ground Floor, Natividad Hall, Bulacan State University, Guinhawa, City of Malolos, Bulacan 3000. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

- 8. The *Bulacan State University* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
