Prospective bidders should have an experience of having completed within **ten (10) years** from the submission of bids, a single contract that is similar to this Project, equivalent to at least fifty percent (50%) of the approved budget for the contract adjusted to current prices using the National Statistics Office consumer price index. The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criterion. Post-qualification of the lowest calculated bid shall be conducted.
