Negotiated Procurement for the Supply and Delivery of Diploma Forms and Holders Project reference no. (G-2019-05)

In view of the two (2) failed public biddings as resolved in Bulacan State University (BulSU) BAC Resolution nos. G-2019-39 and G-2019-91, the BulSU through the Fiduciary Fund 2019 intends to apply the sum of Two Million One Hundred Fifty Thousand Pesos Only (\$\bigsep\$ 2,150,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for "Negotiated Procurement for the Supply and Delivery of Diploma Forms and Holders."

The following eligibility and technical documents, as well as the Financial Proposal Form (Form "E") and itemized bid prices (Form "F"), shall be submitted on or before April 8, 2019 (Monday), 8:30 a.m. at the Procurement Office 2<sup>nd</sup> Floor, CSSP Building (near Gate 4), Bulacan State University, City of Malolos, Bulacan. The number of set of documents is one (1) original and three (3) certified photocopies of the first (Eligibility/Technical) and second components (Financial) of its bid duly signed and sealed:

#### Legal Documents

- Registration certificate from the Securities and Exchange Commission (SEC) or Department of Trade and Industry (DTI) for sole proprietorship;
- Mayor's permit issued by the city or municipality where the principal place of business of the prospective bidder is located; and
- 3. Audited financial statements, stamped "received" by the Bureau of Internal Revenue (BIR) or its duly accredited and authorized institutions, for the preceding calendar year, which should not be earlier than two (2) years from bid submission
- 4. PhilGEPS Certificate of Registration (Platinum Membership)
- 5. NFCC computation in accordance with ITB Clause 5.5 or a committed Line of Credit from a universal or commercial bank

- 6. Statement of the Bidder's Single Largest Completed Contract (SLCC) within the last three (3) years which is similar in nature.
- 7. Statement of all its on-going government and private contracts, including contracts awarded but not yet started, *if any*.
- 8. Bid Security / Bid Securing Declaration
- 9. Statement of conformity with schedule of requirements and technical specifications
- 10. Sample of products/items
- 11. Very satisfactory performance rating from the concerned end-user unit (for previous supplier of BulSU)
- 12. Omnibus Sworn statement in accordance with Section 25.3 of the IRR of RA 9184 and using the form prescribed herein as (FORM "D")

- 14. Itemized Bid Prices (Form "F")
