INVITATION FOR NEGOTIATIONS:

Re-Negotiated Procurement of Mini Bus and Sedan for Bulacan State University
Project reference no. (G-2019-01)

1. The *Bulacan State University (BulSU)*, through the *General Fund 2018* intends to apply the sum of **Eight Million Pesos Only (Php 8,000,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for *Re-Negotiated Procurement of Mini Bus and Sedan for Bulacan State University (G-2019-01)*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. Pursuant to Section 53.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, we invite legally, technically and financially capable suppliers to negotiate with the GPPB-TSO on subject requirement. Please submit your eligibility and technical documents (as per attached Checklist of Requirements for Bidders) in sealed envelopes marked **"Bid Documents for Re-Negotiated Procurement of Mini Bus and Sedan for Bulacan State University"** time stamped not later than **9:00 P.M.**, on **17 May 2019**.
3. Delivery of the Goods shall be in accordance with the Delivery Schedule under Schedule of Requirements. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project.
4. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
5. Interested bidders may obtain further information from *Bulacan State University* and inspect the Bidding Documents at the address given below during *office hours from 8:00 a.m. to 5:00 p.m., Monday to Friday (Except on holidays)*.
6. A complete set of Bidding Documents may be acquired by interested Bidders from the address below, free of charge.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Bulacan State University.

7. The *Bulacan State University* will hold a Negotiation on **May 10, 2019 (Friday), 9:00 a.m.** at the University Hostel 3rd Floor, BAC Conference Room, BulSU City of Malolos, Bulacan 3000, which shall be open to prospective bidders. To ensure

completeness and compliance of bids, bidders are advised to send not more than two (2) technical and/or administrative representatives who will prepare the bidding documents.

8. Final offers must be duly received by the BAC Secretariat at the address below on or before **May 17, 2019 (Friday), 9:00 a.m.**

Bid opening shall be on **May 17, 2019 (Friday), 9:00 a.m.** at the Alumni Affairs Office 2nd Floor, Bulacan State University, Guinhawa, City of Malolos, Bulacan 3000. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The **Bulacan State University** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
