**RE-NEGOTIATED PROCUREMENT FOR THE PROPOSED MODERN AUDIO VISUAL

In view of the two (2) failed public biddings and one (1) negotiation, the Bulacan State University Bids and Awards Committee for Infrastructure and Repairs (BAC) invites interested bidders to participate in the negotiation for the **Re-negotiated Procurement for the Proposed Modern Audio Visual Room at the College of Arts and Letters (CAL)**, in accordance with Section 53.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) No. 9184, otherwise known as the "Government Procurement Reform Act." Bulacan State University, through the Income (2019) intends to apply the sum of **Three Million Eight Hundred Fifty Thousand Nine Hundred Sixty One Pesos and 13/100 (P3,850,961.13)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Re-negotiated Procurement for the Proposed Modern Audio Visual Room at the College of Arts and Letters (CAL)**.
2. The **Bulacan State University (BulSU)- BAC** will hold a meeting/ negotiation with all interested bidders on **August 22, 2019 (Thursday), 9:00 AM** at the BAC Function Room, 3rd Floor, Hostel, Bulacan State University (Main Campus), City of Malolos, Bulacan.
3. The Eligibility Documents, Technical Proposal, and the Best and Final Offer stated in the attached checklist shall be submitted in one (1) original or certified true copy of the original and three (3) additional photocopies of the first (Eligibility and Technical) and second (Financial) components of the bids on or before **September 3, 2019 (Tuesday), 8:30 AM** at the BAC Function Room, 3rd Floor, Hostel, Bulacan State University (Main Campus), City of Malolos, Bulacan.
4. The opening of the Eligibility Documents, Technical Proposal, and Best and Final Offer will be on **September 3, 2019 (Tuesday), 9:00 AM**, at the BAC Function Room, 3rd Floor, Hostel, Bulacan State University (Main Campus), City of Malolos, Bulacan.

Best and final offers received in excess of the ABC shall be automatically rejected.

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

5. Interested bidders may obtain further information from **Bulacan State University-Procurement Office** and inspect the Bidding Documents at the address given below **during office hours from 8:00 a.m. to 5:00 p.m., Monday to Friday (Except on Holidays).**

The **Bulacan State University** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
