The **BULACAN STATE UNIVERSITY (BulSU)**, through its **Bids and Awards Committee (BAC)** for **Goods, Supplies, and Services**, invites suppliers/manufacturers/distributors to apply for eligibility and to bid for the hereunder project:

Delivery Period : **Thirty (30) Calendar Days**

Prospective bidders should have an experience of having completed within the last three (3) years a single contract that is similar to the contract to be bid, and whose value, adjusted to current prices using the wholesale consumer price index, must be at least fifty percent (50%) of the approved budget for the contract to be bid. The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criterion. Post-qualification of the lowest calculated bid shall be conducted.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference(s), Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Revised Implementing Rules and Regulations (IRR).

**INVITATION TO BID FOR
Supply and Delivery of Diploma Holders (BulSU-BAC-G-2020-15)**

1. The *Bulacan State University (BulSU)*, through the *Fiduciary Fund 2020* intends to apply the sum of **One Million Seven Hundred Thousand Pesos Only (₱ 1,700,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Supply and Delivery of Diploma Holder (BulSU-BAC-G-2020-15)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Bulacan State University (BulSU)* now invites bids for **Supply and Delivery of Diploma Holders (BulSU-BAC-G-2020-15)**. Delivery of the Goods is required within **Thirty (30) calendar days upon receipt of Notice to Proceed and Purchase Order**. Bidders should have completed, **within the last three (3) years** from the date of submission and receipt of bids (February 24, 2020), a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

In addition, bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from *Bulacan State University* and inspect the Bidding Documents at the address given below during *office hours from 8:00 a.m. to 5:00 p.m., Monday to Friday (Except on holidays)*.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **February 03 to 24, 2020** from the address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of One Thousand Seven Hundred Pesos (₱ 1,700.00)*.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Bulacan State University, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than **February 24, 2020**.

6. The **Bulacan State University** will hold a Pre-Bid Conference on **February 10, 2020 (Monday), 8:30 a.m.** at University Hostel 3rd Floor, BAC Conference Room, Bulacan State University, Guinhawa, City of Malolos, Bulacan 3000, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat at the address below on or before **February 24, 2020 (Monday), 8:30 a.m.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on **February 24, 2020 (Monday), 8:35 a.m.** at University Hostel 3rd Floor, BAC Conference Room, Bulacan State University, Guinhawa, City of Malolos, Bulacan 3000. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The **Bulacan State University** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
