The BULACAN STATE UNIVERSITY (BulSU), through its Bids and Awards Committee (BAC), invites contractors to apply for eligibility and bid for the project hereunder described:

Name of Project : Tiling of Rooms, Stairs and Corridors

Location : Bulacan State University, Hagonoy Campus, Hagonoy, Bulacan

ABC : **Php 1,661,956.59**

Completion Date : Forty (40) Working Days

The prospective bidder must have an experience of having completed at least one (1) contract that is similar to the contract to be bid, and whose value, adjusted to current prices using the NSO consumer price indices, must be at least fifty per cent (50%) of the ABC to be bid: Provided, however, That contractors under Small B Categories C&D without similar experience on the contract to be bid may be allowed to bid if the cost of such contract is not more than fifty per cent (50%) of the Allowable Range of Contract Cost (ARCC) of their registration based on the guidelines as prescribed by the PCAB. The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criterion. Post-qualification of the lowest calculated bid shall be conducted.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference(s), Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulations (IRR).
