The **BULACAN STATE UNIVERSITY (BulSU)**, through its **Bids and Awards Committee (BAC)**, invites contractors to apply for eligibility and bid for the project hereunder described:

Name of Project : **Modern Audio Visual Room at Laboratory High School (LHS)**  
Location : Bulacan State University (Main Campus), Carpio Hall, City of Malolos, Bulacan  
Scope of Work : General Requirements, Site Preparatory Works, Civil/ Structural Works, Carpentry Works, Tile Works, Wall, Column and Floor Finishes, Painting Works, Fenestrations, and Electrical Works  
PCAB License : Size Range – Small B, License Category- C & D  
Similar Project : Commercial Interior Fit-outs as specified in the scope of works of the project costing at least fifty percent (50%) of the ABC amounting to ₱ 2,061,318.61  
ABC : ₱ 4,122,637.22  
Completion Date : Sixty (60) calendar days

The prospective bidder must have completed a Single Largest Completed Contract (SLCC) that is similar to the contract to be bid, and whose value, adjusted to current prices using the PSA consumer price indices, must be at least fifty percent (50%) of the ABC to be bid: Provided, however, that contractors under Small A and Small B Categories without similar experience on the contract to be bid may be allowed to bid if the cost of such contract is not more than the Allowable Range of Contract Cost (ARCC) of their registration based on the guidelines as prescribed by the PCAB. The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary “pass/fail” criterion. Post-qualification of the lowest calculated bid shall be conducted.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference(s), Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulations (IRR).

The Bulacan State University (BulSU), through the Income Fund 2020 intends to apply the sum of Four Million One Hundred Twenty Two Thousand Six Hundred Thirty Seven Pesos and 22/100 (₱ 4,122,637.22) being the Approved Budget for the Contract (ABC) to payments under the contract for Modern Audio Visual Room at Laboratory High School (LHS) I-2020-17. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The BulSU now invites bids for Modern Audio Visual Room at Laboratory High School (LHS) I-2020-17. Completion of the Works is required within Sixty (60) calendar days upon receipt of Notice to Proceed. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II- Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from the BulSU-Bids and Awards Committee (BAC) Secretariat through the contact details given below and inspect the Bidding Documents as posted on the websites of the BulSU and the Philippine Government Electronic Procurement System (PhilGEPS).
5. A complete set of Bidding Documents may be acquired by interested Bidders on **July 29, 2020** from the address below and upon payment of a fee in the amount of Four Thousand Two Hundred Pesos (₱ 4,200.00). BulSU implements a four-day work week (Tuesday to Friday) 7:30 a.m. to 6:30 p.m., until further notice.

It may also be downloaded free of charge from the website of the PhilGEPS and the website of the BulSU, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than **August 18, 2020**.

6. The BulSU will hold a Pre-Bid Conference on **August 6, 2020 (Thursday), 2:00 p.m.**, which shall be open to all interested parties. To reduce the risks and hazards of community transmission of COVID-19, the BAC shall conduct meetings and conferences via Google Meet platform at <https://meet.google.com/jiz-nmfx-ptg> until further notice, or until such time that the state of calamity, or implementation of community quarantine or similar government restrictions shall have been lifted by the proper government authorities.

Bid opening shall be on **August 18, 2020 (Tuesday), 2:00 p.m.** at the College of Education Library, 3rd Floor, Roxas Hall, BulSU Main Campus, City of Malolos, Bulacan 3000. Late bids shall not be accepted.

**To minimize face to face transaction with the public, only one (1) representative for each bidder will be allowed during the opening of bids.**

8. The BulSU reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.


